

**YOURLAND DEVELOPMENTS INTERIOR DESIGN
VIRTUAL CONSULTATION GIVEAWAY**

TERMS AND CONDITIONS

1. The Promotion

- 1.1 By entering or otherwise participating in the YourLand Interior Design Virtual Consultation Giveaway (“Promotion”), you are deemed to have read and accepted these Terms and Conditions. If you do not agree with these Terms and Conditions, you should not enter, or participate in, the Promotion.
- 1.2 The promoter is Yourland Management Pty Ltd ACN 151 294 852 of 57A Queen Street, Bendigo Victoria 3550 (“Promoter”).
- 1.3 The Promotion commences at 9:01am AEST on 22 August 2020 and closes at 10.59am AEST on 2 September 2020 (“Promotion Period”).
- 1.4 There will only be one (1) winner and one (1) prize awarded.

2. Conditions of Entry

- 2.1 To be eligible to enter this Promotion, an individual must be a resident of Victoria, Australia and aged 18 years or over. Employees, directors and other representatives of the Promoter are ineligible.
- 2.2 Incomplete entries may be deemed to be invalid at the discretion of the Promoter.
- 2.3 The Promoter is not responsible or liable for any attempted entries that are not received for any reason, illegible entries, incorrect transcription of entry information, technical failures of any kind in relation to entry to the Promotion, the unavailability of any service in relation to entry to the Promotion, third party interference and technical or human error in relation to the administration of the Promotion. - 4.4 The winner will be required to schedule their consultation with the Promoter within 30 days of the prize being awarded.
- 4.5 The prize is valid until 31st December 2020.
- 4.6 The consultation must be booked to be completed prior to the expiry date noted in 4.3.
- 4.7 Cancellation within 72 hours of confirmed appointment will result in the prize being forfeited.
- 4.8 The Prize is subject to:
 - a) Availability of the Professional Stylist
